**ISSUE OF LEGEND MINING LIMITED SHARES – SECONDARY TRADING NOTICE  
NOTIFICATION PURSUANT TO PARAGRAPH 708A(5)(e) OF THE CORPORATIONS  
ACT 2001 (Act)**

On 24 November 2011, Legend Mining Limited (**Company**) issued 240,000,000 fully paid ordinary shares, at an issue price of \$0.03 each (**Securities**).
